COOPERATION IN THE AREA OF ARBITRATION

In belief that the commercial arbitration, mediation and other forms of alternative dispute resolution, through a fair and efficient procedure, can contribute to trust and stability in business relations, both parties have agreed as follows:

- 1. The parties shall cooperate on upgrading the arbitration, mediation and other forms of alternative dispute resolution, as the ways to resolve the disputes arising from business relations.
- The parties shall exchange information and publications relating to commercial arbitration, mediation and other forms of alternative dispute resolution in any suitable way, either by e-mail or in printed form.
- 3. Whenever possible, the parties shall foster lectures of mutual interest in the area of commercial arbitration, mediation and other forms of alternative dispute resolution.
- 4. The parties shall promote wider use of arbitration under their auspices, through conferences, seminars and other means.
- 5. The parties shall cooperate on improvement of the commercial arbitration and exchange all necessary information and opinions, with the aim to implement the present addendum.
- 6. Both Parties shall jointly encourage arbitration projects under their auspices.

ADDENDUM N°2

To the Memorandum of Understanding between the Chamber of Commerce and Industry of Serbia and the Kosovo Chamber of Commerce signed on 24 July 2013

INSTITUTIONAL BUILDING AGREEMENT

Within the framework of the Memorandum of Understanding signed on 24 July 2013 in Brussels between the Chamber of Commerce and Industry of Serbia (CCIS) and the Kosovo Chamber of Commerce (KCC);

Considering the benefits that the business communities could draw from the establishment of sustainable institutional relations between the CCIS and the KCC;

Mr. Željko Sertić, President of the CCIS

And

Mr. Safet Gërxhaliu, President of the KCC

Have agreed as follows:

Article 1

A representative of the CCIS nominated by December 20th, 2013 will be posted in the KCC on January 3rd, 2014 and vice versa a representative of the KCC will be nominated by December 20th, 2013 and will be posted in the CCIS on January 3rd, 2014.

Article 2

The mission of the Chamber representative will be to enable direct contact between two chambers in all relevant issues.

Article 3

Logistic aspects related to the implementation of this agreement will be subject to separate arrangements.

Article 4

Both parties agree to review the terms of the agreement within one year and to develop additional institutional building activities accordingly.

Article 5

Any modifications and amendments to this agreement must be approved by the competent bodies of each organisation.

Article 6

This agreement may be terminated by either Party by written notice to the other party within 30 days notice.

The present agreement shall enter into force upon its signature.
